Skills assessment is a tool commonly used on the labour market in order to analyze skills, abilities, attitudes and motivations with the objective of enabling the beneficiary to define a professional career. In some European countries, like France, this tool is already experimented for years in

various contexts and with various targets, with standardized contents and implemented procedures.

The project idea is based on a collaboration at European level to adjust the assessment of competences used in a career guidance context, into a voluntary service context.

The partnership is also oriented to share specific methodologies of accompaniment of volunteers used by the different partner organizations, as well as to develop a strategy to use the European Skills Passport and the EQF in volunteering organizations.
